## EASY & PRODUCTIVE

e-Share's File Sharing and Secure Email platform makes sharing information externally simple. It works how recipients want to work, with the tools they already use.

- **File sharing from Outlook, Teams, Office Apps, OneDrive and SharePoint** – Via org-deployed add-ins and bots, e-Share is an extension of the apps and workflows your users are using today.
- **No file copying or version confusion** – The use of OneDrive and SharePoint for all file storage eliminates the file copying necessary with point solutions.
- **Modern collaboration** – Zero Transfer File Sharing via links enables online editing and co-authoring of shared files and the dynamic creation of Virtual Data Rooms. And it ensures everyone is working from the same version of shared files.
- **File sharing with your users** – Outside parties can upload files on-demand into a dynamically created shared folder in your user's OneDrive. This is invaluable when files are too big or too sensitive for email and when your organization blocks links to file sharing services, as many do.
- **Automated protection of shared files** – Via Azure Information Protection or 3rd party DLP shared files can be secured with no action required on the part of users (e.g. email attachments replaced with links)
- **No Passwords for Recipients to Manage** – The use of OpenID and SmartURLs makes it simple for recipients to receive, view, comment, edit and even message with other document editors without the need to register for an account or remember a new password.
- **Rapid adoption** – By leveraging O365 applications, the deployment and adoption of e-Share across the enterprise requires negligible little end user training.



## BRAND SAFE & RELIABLE

e-Share's Secure File Sharing platform allows organizations to use their trusted domain name and branding to share and collaborate with their clients, partners and suppliers.

- **No Link Blocking** – Links from Google Drive, Box, OneDrive, Dropbox, and even OneDrive and SharePoint are often blocked by a recipient's IT team in fear of data loss, and also blocked by China as part of its national censorship program. But with e-Share, links are sent from your organization's sub-domain and implicitly trusted, yielding file sharing that is every bit as reliable as email.
- **100% Private Branding** – e-Share allows you to present a branded collaboration UX to external parties, using your logo, colors, terms of use, etc. This branding strengthens your brand, instills trust on the part of clients, suppliers and partners, and minimizes the phishing concerns recipients would otherwise have.
- **Branded Recipient Emails & Notifications** – All emails sent by e-Share come from your users, not a vendor account. No more looking for secure emails and file sharing notifications in junk mail folders.



## SECURE & COMPLIANT

e-Share's Secure File Sharing platform provides an advanced layer of information management capabilities that deliver fine-grained access, shared file use tracking, regulatory compliance and privacy controls.

- **Zero Transfer File Sharing** – All files are shared via links, with all files securely stored in your OneDrive and SharePoint. Links allow file sharing without giving data away in all cases.
- **Control Shared Files** – 32 sharing controls, such as view only, online editing, dynamic watermarking and more, are rolled into user or DLP applied sharing policies that the organization defines.
- **AIP integration** – e-Share uses AIP document labels to limit what files can be shared with external parties. Labels are evaluated in real-time, allowing dynamically changing content to be protected.
- **Actionable Reporting & Data Analytics** – Detailed audit logs can be output to Splunk or some other SIEM, are viewed within e-Share's Power BI based reports and dashboards.
